GHG emissions quantification is also one of the important targets in the Implementation Guidance for Climate Disclosures under HKEX ESG reporting framework to measure its climate-related risks and opportunities.

Auditors are expected to be capable with the knowledge and skills needed to assure accuracy, consistency and certainty in carbon accounting and preparing carbon audit and ESG reports. The talk provides the background information on the relevant standards on carbon audit; market opportunity, professional qualifications and development of auditors; carbon audit/validation/verification and sustainability reporting.

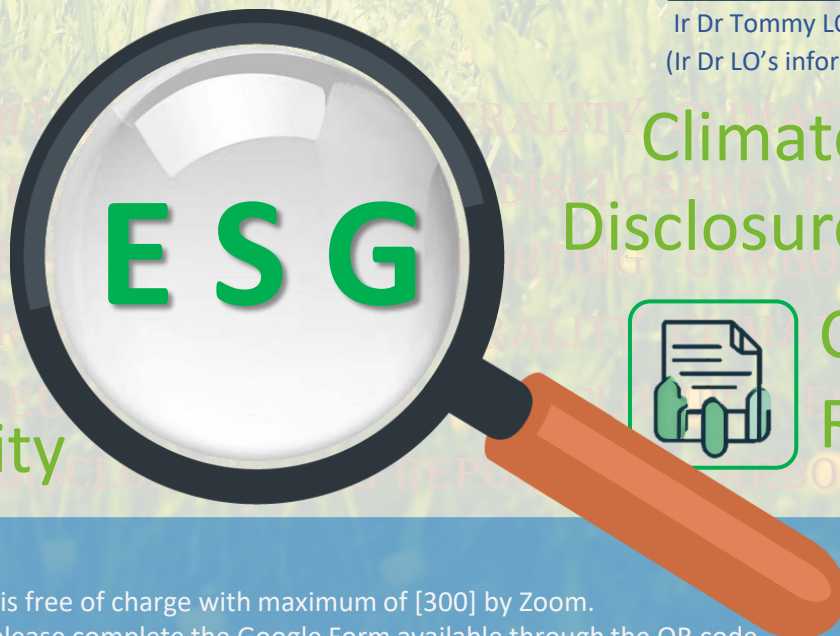
